SURFIN Special Session to Focus on European Nickel Cancer Labeling and Chemicals Decisions

The "globalization of regulation" phenomenon has meant new challenges for the surface finishing industry in recent years. Job shops and suppliers in the automotive, electronics, aerospace and other sectors have made major commitments in time, resources and technology innovation to comply with expansive European mandates restricting certain metals and chemicals in products.

Just as the industry was mastering the new reality of product-based rules for chromium, cadmium and lead under the automotive (ELV) and electronics (RoHS/ WEEE) directives, the European Union is now moving to mandate major cancer classification and labeling requirements under its *Dangerous Substances Directive* for over 140 nickel compounds, including nickel carbonate, nickel sulfate and other basic materials used in finishing.

Potential Impacts for Nickel Coatings

The NASF Government Relations program has been monitoring nickel science and regulatory activity in the U.S. and the European Union for some time. With the new nickel decisions, the NASF is concerned that these decisions could have major economic impacts on the industry, including:

- new reporting requirements,
- new regulatory controls under the EU REACH chemicals legislation and other requirements; and
- disruption of nickel uses in the major finishing supply chains.

The NASF is now launching a major effort, in collaboration with the Nickel Institute, to oppose implementation of the new nickel classification and labeling scheme. Among other activities, the NASF is working to prompt the US Trade Representative to join 16 other nations – including Canada and Australia – and formally oppose the EU decision at the World Trade Organization's Technical Barriers to Trade Committee.
